OHIO REVISED CODE §5705.03 (B)**

Whereas, the Bath Township Board of Trustees in their desire to make informed decisions for future planning of Bath Township, need to know the amount of revenues a 2- mill levy would generate; and,

Whereas, Bath Township has a continuous 1.5 - mill Police Levy; and,

Whereas, the trustees wish to place a 1.5-mill replacement levy with an increase to a 2-mill levy on the November 3, 2015 ballot for the purpose of providing for capital expenditures, wages, benefits, operation and maintenance of the Bath Township Police Department and facilities;

Now Therefore Be It Resolved that the Bath Township Board of Trustees hereby requests that the Summit County Fiscal Officer calculate said millage expressed in dollars and cents for each one hundred dollars of valuation for a 2-mill replacement police levy for tax year 2015 and collection year beginning in 2016.


